

# CHILDHOOD BEREAVEMENT CHANGEMAKER (CBC) INITIATIVE REQUEST FOR PROPOSAL

The <u>Childhood Bereavement Changemaker Initiative</u> is an evaluation capacity building program that was developed by Judi's House/JAG Institute in partnership with the New York Life Foundation to support agencies in understanding and using data to strengthen services for bereaved children and families.

The Childhood Bereavement Changemaker (CBC) initiative allows participating organizations access to a unique, sequenced, evaluation training model. The model includes interactive workshops, expert consultation, program evaluation resources and templates, and peer networking. After fully engaging in this learning process, organizations will be equipped with data to inform planning, influence change, increase funding, and enhance overall impact—ultimately ensuring bereaved children in their community have the care they need.

Selected *Childhood Bereavement Changemakers* (*Changemakers*) will participate in a series of four two-hour workshops in preparation for completing capacity building activities and templates. Between workshops, *Changemakers* will participate in group and individual technical assistance sessions with the Judi's House/JAG team to support these activities. A Readiness Assessment will estimate each interested applicant's current evaluation capacity. *Changemakers* will become part of our extended alumni network. This network of partners and collaborators supports organizations tackling similar obstacles to create a broad learning community dedicated to elevating evaluation practice and data utilization in the field. Offered at no cost to participants, the initiative provides selected *Changemakers* unparalleled support and continuing education credits where applicable.

#### Selected Changemakers will receive:

- Access to and support utilizing the CBC Program Evaluation Online Workbook of resources and templates to support best-practice evaluation implementation
- Collaboration with the experienced Judi's House/JAG Institute Team of evaluation researchers
- Access to Judi's House/JAG Institute resources and networks
- Meeting coordination and forum for *Changemaker* Learning Community
- Four Evaluation Workshops
- Four group assistance sessions
- Hands-on learning through individual assistance sessions
- Practical recommendations
- Connection and engagement with local and national partners in the childhood bereavement field
- Identification as a partner in the Childhood Bereavement Changemaker Initiative

Judi's House/JAG anticipates engaging one Changemaker Cohort each year. Cohort engagement will be as follows:

April 2024-March 2025

March 2025-February 2026

March 2026-February 2027

March 2027-February 2028

Judi's House/JAG will post a *Changemaker* Request for Proposal (RFP) each year in November for organizations interested in participating in the following year's March cohort start.

In addition to the CBC Initiative, Judi's House/JAG Institute offers a series of free evaluation trainings in partnership with the National Alliance for Children's Grief (NACG). These trainings are an alternative resource for organizations who cannot dedicate sufficient time to the year-long CBC initiative. The evaluation training series is a great way to begin building evaluation capacity.

This RFP is for the April 2024—March 2025 *Childhood Bereavement Changemaker* cohort. Organizations committed to growing their evaluation capacity to elevate childhood bereavement with the necessary time and resources to dedicate to the CBC process should review the entire RFP and **submit a completed application online**<sup>†</sup> **no later than 5 pm MDT on Friday, March 1, 2024**.

<sup>†</sup>Only Childhood Bereavement Changemaker Applications submitted online will be considered.

#### **Benefits for Changemakers**

- Strengthen understanding of evaluation planning and implementation, data collection, and data utilization
- Access essential data to drive decision making for organizational growth and enhanced impact
- Build connections with local and national partners through thoughtful dialogue about field-specific data and evaluation best practices
- Collaborate with Judi's House/JAG Institute Team of multi-disciplinary experts
- Inform planning, influence policy change, and increase funding
- Free evaluation consultation, typically invoiced at \$250/hour
- Changemakers are eligible for ongoing consultation at a discounted rate upon cohort completion
- Improved understanding of the Childhood Bereavement Estimation Model resources and their local relevance
- Recognition as a valued Changemaker partner on the Judi's House/JAG Institute website

#### **Changemaker** Investment

- Staff Time/Resources
  - Based on previous Changemakers' experiences, your team can expect to spend 8-12 hours/month across the 12-month participation
- Knowledge and information sharing
- Stakeholder engagement

#### **Changemaker** Requirements

- Participate in four virtual evaluation workshops
- Prepare for & participate in four virtual group technical assistance sessions
- Prepare for & participate in monthly individual technical assistance sessions with Judi's House/JAG team
  - Meet via Zoom, utilize online resources and share documents for review and collaboration through a
    designated online platform, collaboratively develop agendas for sessions through the online platform
- Attend annual in-person collaborative meeting in conjunction with 2024 NACG Symposia
- Implement practical recommendations
- Review and/or provide critical feedback on Judi's House/JAG Institute deliverables
- Adhere to general CBC Initiative Timeline and approved partner-specific timelines
- Maintain consistent communication throughout collaboration

#### What *Changemakers* will receive

Training and consultative program valued at over \$60,000 to include:

- Interactive workshops
- Evaluation workbook resources and templates to support best practice program evaluation
- Evaluation assistance alongside other Changemakers
- Individual assistance, including review of Changemaker-developed evaluation tools
- Practical recommendations
- Meeting coordination and forum provided for Changemaker Learning Community

#### What the Changemaker Initiative is Not

- A chance to obtain an already-created evaluation protocol and data collection tools for your organization to adopt.
  - o Instead, it is an opportunity to refine or develop new tools in collaboration with experts at Judi's House/JAG based on your organization's evaluation goal/questions and your specific program.
  - Your team will build capacity, with support from the Judi's House/JAG Institute team, to develop
    evaluation questions to guide your program evaluation effort and data collection tools to complement
    your program and participants.
  - There is not a one-size-fits-all solution in program evaluation. This initiative involves learning alongside
    other organizations working in the family bereavement field who are invested in improving their
    evaluation practices and utilizing data to drive decisions, improve programming, and increase funding
    towards sustainability.
- The CBC Initaitive is not a certification program.
  - Changemakers will have the opportunity to earn continuing education credits for counseling or social work.

April 2024 - March 2025: Changemakers participate in CBC Initiative

#### **CBC Process**

Across each of four evaluation capacity building modules, the JH/JAG Team engages participating organizations through the following training model:

Interactive Workshop (2 hours)
Individual Assistance Sessions (one 1-hour session/month)
Group Assistance Session (2 hours)

#### **Training Modules:**

Module 1 Preparation	Supports <i>Changemakers</i> in getting started with basic program evaluation, including capacity assessment, stakeholder engagement, defining their model, setting goals, identifying barriers, and evaluation planning
Module 2 Planning	Prepares <i>Changemakers</i> to select initial data to collect, create data collection tools and protocols, as well as plan for data cleaning and analysis and begin data collection
Module 3 Implementation	Support ongoing data collection while setting up <i>Changemakers</i> for analysis, interpretation, and reporting
Module 4 Data Utilization & Reflection	Strengthens <i>Changemakers'</i> data utilization skills, including planning for internal data discussions, surfacing learnings, adjusting data collection plans, making data-informed decisions, utilizing data to tell their story of impact to stakeholders, and acting on findings

#### 1. Program Goals Identified

Organization has program goals and objectives.

Program descriptions are consistent and clear.

Program activities align to the organization's mission.

Organization has documentation that outlines program model, which may be a logic model, work plan and/or program planning and evaluation model.

#### 2. Measurable Outcomes

Organization has clear measurable outcomes that align to the mission statement.

All staff are aware of these measurable outcomes.

These outcomes identify what change is expected to occur, in what way, and with what group(s).

Example: More than half of program participants show improvements in grief-related symptoms.

#### 3. Data Collection Tools

Organization has data collection tools that measure the outcomes. This may include intake forms, surveys, focus group question guides, and other methodologies.

#### 4. Data Collection Process

Organization has at least one staff member charged with overseeing all data collection efforts. A third-party evaluator may also be involved.

Data collection protocol is established.

Data collectors are trained.

Written documentation about data collection process, confidentiality, and data security is in place.

#### 5. Data Management

Organization has a data management system in place.

There is a process to enter data (if collected on paper).

There is a database that can be managed internally or externally.

There is a codebook to ensure data are managed in a consistent manner.

There is a data management training for staff and/or volunteers.

#### 6. Data Analysis and Reporting

Organization has identified parties that have the time and skills to analyze data and synthesize into a meaningful report.

#### 7. Communicate Data

There is a clear communications plan of how evaluation reports will be shared with different groups, such as funders, participants, staff, board members, and the community at large (if applicable).

#### 8. Usage of Data

Organization uses data for continuous program improvement as well as accountability to key stakeholders.

There is a culture of evaluative thinking, where data-based decision making is integrated into the organization's culture.

By submitting the completed *Childhood Bereavement Changemakers* Application, the organization agrees to contribute all investments, meet all requirements, and abide by all timelines outlined in the *Childhood Bereavement Changemaker* Request for Proposal.
