



Use this action plan to strengthen **YOUR** impact and elevate childhood bereavement as a critical priority.

## Step One: Gather relevant CBEM data

Review the [2025 CBEM National and State results](#). You can access additional 2025 CBEM results via the new [CBEM Dashboard](#).

**Projected CBEM Prevalence:** These results combine estimates of a) the number of children who are **already bereaved** and b) the number of children who **will experience** bereavement. Use Projected results to:

- Forecast service and systems demands
- Cultivate public awareness and engagement
- Engage in advocacy and policy efforts
- Evaluate best practices
- Build workforce capacity
- Secure financial support

**Current CBEM Prevalence:** These results reflect the number of youth who **have already experienced** bereavement. Use Current results to:

- Address service and systems demands
- Identify service gaps
- Implement best practices
- Share grief resources
- Explore bereavement trends
- Secure financial support

**Snapshot CBEM Prevalence:** These results use the Current model and examine one year of input data to provide the number of children **newly bereaved** in a specific year. Use Snapshot results to:

- Examine point-in-time prevalence
- Communicate the magnitude of childhood bereavement in a relatable way
- Compare year-over-year changes
- Secure financial support

**Source of Bereavement:** These results are available for youth populations up to ages 18 and 25.

- Death of a Parent results at the national, state, and county levels.\*
- Death of a Sibling and Death of a Parent or Sibling results are available at the national and state levels.

## Step Two: Put the data in context

Use the Dashboard to search CBEM results specific to your location of interest and complete the following statements:

\*NOTE: 2025 county-level CBEM data will be released this fall. Prior results were released in 2020. CBEM county-level results released prior to 2025 may reflect an undercount because they exclude pandemic data. In 2021, we released CBEM Data Tables by Race & Ethnicity, which are expected to be updated in 2026.
